# VACo Conference update




If you're attending <u>VACo's Annual</u> <u>Conference</u> here are a few helpful suggestions we'd like you to consider.

VACo asked Republican Ken Cuccinelli, Democrat Terry McAuliffe and Libertarian Robert Sarvis to state their positions on three issues pertinent to counties. VACo thanks the gubernatorial candidates for participating.

**Local Business Taxes** (BPOL, Machinery & Tools and Merchants Capital)

#### **VACo's Position**

**Cuccinelli:** In anticipation of the effects of federal budget cuts and the need to jump start small business growth within Virginia to offset the spending cuts, it is critical that pro-growth tax reform be implemented to increase jobs and provide tax relief for Virginia's families. **(Continued on Page 8)** 

**McAuliffe:** Regarding local business taxes, I have been clear that I have two goals, which should not be in conflict if properly approached. First, I would like to give local governments the ability to reduce or eliminate these taxes if that's a goal they would like to pursue. Second, I will not support proposals that would reduce a local government's ability to maintain its revenue structure. **(Continued on Page 8)** 

**Sarvis:** Local business taxes are inefficient ways to raise revenue, and they lack transparency, hiding the cost of government from voters and overly burdening businesses. They should be eliminated, and local governments should be given authority to raise revenue via a more efficient, more transparent, broad-based tax. **(Continued on Page 8)**

Here are a few tips to make arrival and departure from The Omni Homestead Resort work out more smoothly.

#### **UPON ARRIVAL**

### **Roanoke County names Director of Economic Development**

County Administrator Clay Goodman this week named Jill B. Loope the Director of Roanoke County's Economic Development Department. Loope, has worked for Roanoke County for more than 13 years – most recently as Acting Director of the department. Her appointment was effective October 1.

Most recently Loope and her staff led Roanoke County's effort to recruit the Ardagh Group to purchase the former Hanover Direct distribution center. Ardagh, a global manufacturer of metal packaging products for the food industry will employ 96

people initially. Since the announcement, Canline Systems an international supplier of conveyor systems selected Roanoke County for its first U.S. facility to supply the Ardagh operation.

Loope begin her career with Roanoke County in 2000 as Director of Community Relations. Less than a year later, she transferred to the Economic Development Department as Assistant Director and was named Acting Director in 2011. Prior to joining Roanoke County, Loope worked as Director of Economic Development for Caroline County and the City of Radford, bringing over 22 years of experience in economic development.

## VACo's Preliminary 2014 Legislative Program Released

The Preliminary 2014 Legislative Program is now posted on VACo's website.

The document includes a host of important and timely proposed policy statements including language regarding K-12 education funding, stormwater regulations, employee benefits, state and local fiscal obligations and other critical issues.

The development of the 2014 Legislative Program was initiated in the spring when VACo leaders hosted regional meetings and VACo staff attended various county boards of supervisors' meetings. Those meetings provided VACo members with the opportunity to highlight legislative issues of concern. Steering committees met Aug. 17 in Richmond, and the Resolutions Committee met on Oct. 8 via conference call.

Pocahontas was the favorite daughter of Powhatan, ruler of the Powhatan Confederacy. She was born around 1595, probably at Werowocomoco 16 miles from Jamestown. Captain John Smith believed she saved his life twice during the colony's first years, and during 1608-1609 she was a frequent and welcome visitor to Jamestown, often bringing gifts of food from her father.

From 1609 to 1613 she was part of Indian society and was not seen by the settlers. In April 1613 she was captured by the English while she was living on the Potomac River and was brought to Jamestown as a hostage. She soon converted to Christianity and was baptized.

Her marriage to John Rolfe in April 1614 helped to establish peaceful relations between the Indians and the English. In 1616 she visited England with her husband and infant son, Thomas, and was presented to the Royal Court. While returning to Virginia she died on March 21, 1617 and was buried in St. George's Church in Gravesend, England. Today many Americans claim descent from her through her son and granddaughter.

The statue, by William Ordway Partridge, was erected in 1922 on Jamestown Island. Visit the statue at Preservation Virginia's Historic Jamestowne.

## Washington County Service Authority Selects Milestone Communications to Market Potential Wireless Tower Sites

Wireless infrastructure development and management firm, <u>Milestone Communications</u>, announced it has been selected by Washington County Service Authority (WCSA) to include 68 water/wastewater pump station, water storage and water/wastewater treatment plant locations in a portfolio of available sites for potential wireless infrastructure expansion.



The wastewater system consists of approximately 65 miles of wastewater collection lines, 26 pump stations and two wastewater treatment plants. **Local Business Taxes** (BPOL, Machinery & Tools and Merchants Capital)

**Cuccinelli (continued):** With a reduced corporate tax rate of 4 percent, Virginia would have the lowest maximum corporate tax rate among all 43 states that have a corporate income tax. By reducing the personal income tax rate from 5.75 percent to 5 percent and indexing it to inflation we would lower taxes for the average family between \$400 to \$700 per year. We would have to cap spending at the rate of inflation plus population and eliminate approximately 15 percent of tax exemptions to cover the cost of the tax cuts. This plan would create over 58,000 jobs, increase business investments by \$650 million, and generate real disposable income by \$3.6 billion. Whereas, my opponent's plan, would raise taxes for the average Virginian family by \$1,700 per year.

In terms of local business taxes, I will establish a Small Business Tax Relief Commission with the following strategic goals:

- 1. Seek ways to eliminate or reduce the harmful effects of the Business Professional Occupational License (BPOL) Tax, the Machine and Tool (M&T) Tax, and the Merchants Capital (MC) Tax, while maintaining local government revenue.
- 2. Identify and eliminate outdated exemptions and loopholes to pay for the tax cuts.

My view of all tax credits, preferences or loopholes is that they all should be reviewed at this time for their economic merit. Those that have a proven record of success and will help us weather the federal budget cuts and propel rapid economic growth should remain in place. Those that demonstrate that they no longer offer economic merit should be eliminated with the revenue directed to the localities. Let me be clear, I am well aware of the disparity of revenue levels and value of these local business taxes to local communities. If the localities cannot be kept whole, we will not go forward with the elimination or reduction of these local taxes.

**McAuliffe (continued):** My solution is to convene a commission, made up of local and state elected officials, representatives from VACO, VML, and Virginia First Cities, and tax experts. This commission would be charged with creating a "menu" of new, local revenue streams that could be used to replace or reduce local business taxes. These changes would be completely at the discretion of the locality and should leave them with more options, not fewer.

Regarding broader tax reform, I am open to the idea and look forward to discussing it with leaders in local government, the legislature, and the business community. Tax reform, done properly, can help to buttress the Commonwealth's general fund that finances most core government functions. JLARC recently studied a broad swath of the Commonwealth's tax preferences and there is clearly bipartisan agreement that positive change is possible.

**Sarvis (continued):** I support comprehensive tax reform that replaces as much of the income tax as possible with a uniform consumption tax, i.e., a uniform tax on all final retail sales of goods and services. All loopholes, tax deductions, exemptions, special valuations, special rates, tax credits, etc., should be eliminated.

#### **Funding of Public Education K-12**

#### **VACo's Position**

**Cuccinelli:** The current budget for K-12 education for FY 2014 is \$5,405.1 million from the General Fund and \$1,516.2 million from the Non-General Fund. K-12 Education is one of the largest portions of the General Fund Budget.

Inherent in the current system is the lack of a continuum of rewards and consequences for school performance. Schools and school divisions that excel or perform above average receive no relief from regulatory input requirements. On the opposite end of the spectrum, the state is not empowered to create or enforce real and substantive consequences for schools or school divisions that repeatedly fail to educate children.

Therefore I intend to provide local jurisdictions with block grants with the Standards of Quality absent the mandates to enable local school boards to have flexibility to fund staffing for classroom needs.

**McAuliffe:** As Governor I will support full funding for the biennial re-benchmark of Virginia's Standards of Quality (SOQ). It is essential for the state to fund fully its constitutional responsibilities and all mandates associated with K-12 public education.

While the coming budget may present challenges, it has always been my view that education is an investment, not an expense, and one we should fund as fully as budget conditions permit.

I am firmly opposed to unfunded mandates on localities whether they are explicit mandates or are hidden in changes to Virginia's school funding formula. The state should properly meet its obligations within the confines of its own budget.

**Sarvis:** The state government should focus on adopting a universal school choice program that empowers parents and teachers rather than politicians and bureaucrats; eliminate mandates on local jurisdictions; eliminate or reform teacher licensure and school accreditation; and eliminate SOLs and SOQs.

I agree that unfunded mandates should be ended, as should many funded mandates as well. State mandates are a source of administrative bloat in the public education system. Local autonomy should be increased, while state efforts and funds are focused on developing a universal school choice program and an open and competitive market place in schools and education services.

#### **Unfunded Mandates especially Unfunded Teacher Liabilities**

#### **VACo's Position**

**Cuccinelli:** At this point, I am concerned about the significant liability that we have in the Virginia Retirement System. I don't think we should borrow from the fund to pay for other budget items when revenues are down. As Governor, I will work to fund the remaining liability as a significant portion of state and public employees vested in the VRS are nearing retirement age now.

I support and appreciate the work of Gov. McDonnell's Task Force for Local Government Mandate Review, and I intend to extend the work of this commission through my term. We will need a local government liaison with the Governor's office and state agencies to continue the work to reduce the local government mandates. I would support a new rule for the General Assembly sessions that any legislation that imposes local government requirements must be introduced on first day of the session to allow the localities, legislative services, the Department of Planning and Budget, and the Tax Department enough time to do a cost benefit analysis that is conducted in a uniform manner. I believe that all mandates should have a sunset clause.

**McAuliffe:** Local governments and the state share responsibility for paying the cost of teacher pensions, but the state government must do all it can to protect the bond ratings of local governments, including taking steps to ensure that the full future liability of teacher pensions does not fall on our local governments in a way that could hurt their bond ratings.

As Governor, I will oppose unfunded mandates by the Commonwealth. When legislation with a cost to localities is passed by the General Assembly, the cost should be borne by the Commonwealth, and the legislation should contain a sunset clause providing that the mandate is not binding on localities until funding by the Commonwealth is provided. I oppose the shifting of fiscal responsibility from the state to localities for existing programs. Any unfunded mandate or shifting of responsibility should be accompanied by a full fiscal support. Fundamentally, it is the responsibility of the state to meet its own obligations, not pass them down to local governments already struggling to provide services to their citizens.

**Sarvis:** State and local governments should pay their share of fully funding the promises made by the pension system. However, state and local governments should not maintain a pension system that makes taxpayers bear long-term pricing and investment risk; instead, we should reform the pension system toward defined contribution plans.

I support getting rid of unfunded mandates, and most funded mandates, too.



# RICHMOND REGIONAL PLANNING DISTRICT COMMISSION ELECTS NEW OFFICERS

The Richmond Regional Planning District Commission (RRPDC) has elected new officers for the only government organization where elected officials from the Richmond Region's nine local jurisdictions come together to develop solutions to shared concerns. **Angela Kelly-Wiecek**, a member of the Hanover County Board of Supervisors, was chosen by her peers to serve as chair for the one-year term.

"I am excited to lead the RRPDC at this time when the region is experiencing a pivotal moment in its history," said Chairwoman Kelly-Wiecek. "In recent years, the RRPDC has significantly increased its role in facilitating collaboration among the localities, building on its strength as the only place where elected officials from all nine local jurisdictions come together to discuss all types of regional issues."

In addition to Chairwoman Kelly-Wiecek, the RRPDC also elected following officers (see attached biographies and photos):

- Vice Chairman: **Ken Peterson**, a member of the Goochland County Board of Supervisors;
- Treasurer: **David Williams**, a member of the Powhatan County Board of Supervisors; and
- Secretary: **Dan Gecker**, a member of the Chesterfield County Board of Supervisors.

Planning district commissions were created in 1968 to "encourage and facilitate local government cooperation and state-local cooperation" (Va. Code Ann. § 15.2-4207). Seats on the RRPDC's 33-member governing board are allocated according to each locality's population.

The board includes 22 locally-elected officials, seven local Planning Commission members and four citizens representing the one million residents of the Town of Ashland, the City of Richmond and the Counties of Charles City, Chesterfield, Goochland, Hanover, Henrico, New Kent and Powhatan.

The RRPDC provides regional services as identified and selected by the locality members and the Commonwealth of Virginia. In recent years, the RRPDC partnered with the Greater Richmond Chamber of Commerce to create the Capital Region Collaborative, a community-wide initiative to identify and implement regional priorities that will enhance the quality of life in the Richmond Region.

In the coming months, the RRPDC will complete a Regional Comprehensive Economic Development Strategy, culminating two years of work with private and public economic development stakeholders.

The RRPDC also manages regional transportation planning, provides technical assistance to local governments and develops geographic information services, including demographic and economic statistics.
