House and Senate budgets reveal broad differences

The Virginia Senate and the House of Delegates released competing budgets that show stark contrasts in health care and other spending priorities.

The Senate Finance Committee and the House Appropriations Committee met on February 16 to unveil their amendments to the two-year, \$96 billion budget that former Governor Bob McDonnell introduced in December.

The most glaring difference is how each chamber chose to address improving health care coverage for Virginia's uninsured, working poor.

The House majority opposes expansion of Medicaid under the Affordable Care Act (ACA). House members remain skeptical that the federal government can afford to fulfill its promise to cover new enrollment costs in a state program House leaders say needs an audit and cost control reforms before any expansion.

Instead, the House proposed to restore \$81 million in inflation adjustments to hospital reimbursements that Governor McDonnell eliminated in the first year of his proposed budget. The House plan also adds \$6 million for free clinics and community health centers that serve people who would be covered by an expanded Medicaid program.

<u>In a VACo interview</u>, Speaker William Howell said the expansion of Medicaid would cost local governments more money because eligibility determination would mean a mandate on local departments of social services.

The Senate's plan, called "Marketplace Virginia," is a private option model. The Senate proposes to recover \$1.7 billion annually of the \$2.9 billion that Virginians send to the federal government in higher taxes and fees under the ACA.

"It's a business solution to the problem of providing health care coverage," said Sen. John Watkins, who proposed the plan. "It's not Medicaid expansion; it's private management. It's what Republicans believe in."

Governor Terry McAuliffe has pressed for Medicaid expansion, stating that Virginia will squander more than \$2 billion a year in federal funding by doing nothing. He has also warned that some hospitals will have to close without expansion because of lost reimbursements under ACA.

Both chambers also differ on light rail. The Senate budget includes \$10 million to study extension of light rail to Norfolk Naval Station and west up the Peninsula. The House budget does not.

Though both budgets contrast in approach and appropriations for mental health funding, both have the same goals of increased bed space and intake centers for people in mental health crises.

Public employee compensation also varied among the budgets. The House offers a conditional 2 percent bonus to state workers while the Senate plan proposes a 1 percent raise and a 1 percent bonus.

VACo will provide additional analysis after budget details are released on February 18.



Hundreds of local leaders flock to Richmond for Local Government Day

Governor Terry McAuliffe addressed more than 400 local leaders on February 6 at Local Government Day.

The governor talked about current issues such as Medicaid expansion, transportation and economic development.

But mostly, the governor urged local leaders to work together in finding solutions to Virginia's issues.

"We have to do it together," Governor McAuliffe said. "The Virginia Way. Finding common ground. Moving together as one.

"As governor, I get out of bed every single day, competing against 49 other states and 200 nations around the world," he added. "I get out of bed wanting to beat every one of them. So do you. Let's do it together."

The Virginia Association of Counties, the Virginia Municipal League and the Virginia Association of Planning District Commissions join forces to co-sponsor Local Government Day every year.

VACo and VML staff members report on legislation affecting local governments, and local officials are encouraged to go to

Hurricane Preparedness: Community Vulnerability and Medically Fragile Populations

In this new article the authors state that our ability to predict and track hurricanes and major storms has grown in recent years. But our understanding of how people will react to warnings and what their needs might be has great room for improvement.

Through news media images, the public has a deep awareness of the fragile nature of our built environment and infrastructure, the authors point out. But in their view a realistic understanding of vulnerability must also consider the resources, social ties and special needs of households and neighborhoods.

Americans have a false perception that people who are most vulnerable to a severe storm, such as the elderly and medically needy, will be likely to evacuate to safety, Behr and Diaz write. In addition, they observe, "We also know that frequent encounters with 'close call' storms may engender household complacency and a false sense of security in dealing with the next storm event."

Using a hypothetical major storm scenario they dub "Sandtrina," the authors conclude that even after proper warning, the eastern areas of Virginia and North Carolina would be highly vulnerable in many ways.

Smith's Fort Plantation


Nestled on the south side of the James River, Smith's Fort Plantation offers a quiet refuge from the bustle of everyday life. Built sometime between 1751 and 1765, the story-and-a-half brick house is laid in Flemish bond and was home to Jacob Faulcon and his family. A gabled roof is accented with dormer windows and the house retains much of the original pine interior paneling and woodwork.

The name "Smith's Fort Plantation" come from the fact that John Smith began construction of a fort on this site in 1608. Directly across from Jamestown on Gray's Creek, Smith's Fort offered a strategic location but was quickly abandoned. Later in that century, Chief Powhatan gave his new son-in-law, John Rolfe, a grant of land as a dowry gift on the occasion of his marriage to Pocahontas although the couple never lived on site.

Preservation Virginia acquired Smith's Fort Plantation in 1933. It has been fully restored and has a fine collection of English and American furnishings. Today, visitors can see the site of the

York County receives AAA rating from Standard & Poor's and saves over \$811,000 on bond refinancing

York County officials were recently notified that bond rating agency Standard & Poor's has upgraded the county's general obligation bond rating to AAA, the highest grade the rating agency issues. In addition, the county's and Economic Development Authority's lease revenue bond ratings were upgraded from AA to AA+.

"We are very pleased to have received these upgrades from Standard & Poor's," said York County Administrator James "Mac" McReynolds. "One of the major areas impacting any community's credit rating is the commitment of its leadership to developing, implementing and sustaining sound financial policies and practices. York County is fortunate to have a Board of Supervisors with a long history of supporting fiscally conservative policies, making decisions focusing not only on the immediate impact but looking to the future as well. It is very rewarding to have received this recognition from an agency that is as highly regarded as Standard and Poor's."



The AAA rating means the agency believes the county is well managed and has a very high ability to repay its debt and that there is a very low risk of default on county bonds. These upgrades should also result in lower interest rates on bonds issued by York County.

In its report, Standard & Poor's attributed the upgrade to the following factors:

- Very strong economy, which benefits from participation in the broad and diverse Hampton Roads area economy coupled with good access to Richmond, VA and its employment base;
- Very strong budgetary flexibility;
- Strong budgetary performance, which takes into account a relatively stable revenue stream;
- Very strong liquidity providing very strong cash levels to cover both debt service and expenditures;
- Strong management with sound financial policies with a consistent ability to maintain balanced budgets; and
- Very strong debt and contingent liabilities position, driven mostly by the county's low net direct debt.

Deputy County Administrator, Vivian Calkins-McGettigan commented, "Receiving the highest bond rating from Standard & Poor's is an accomplishment for the entire York County community including our citizens, businesses, Board of Supervisors, senior leadership and staff, as we were able to demonstrate a long history of decisions focused on the future, a high performing school division with relatively low comparative costs, economic development focused on attracting quality businesses, many decades of emphasis on quality land planning and positive demographic statistics such as our 10 year unemployment rates being consistently below the state and the nation and our highly educated citizens consistently rating their quality of life in York County as very high on formal citizen surveys. When you factor all this together, and so much more, York County's story is very impressive."

The county anticipates posting the bond rating presentation to its website in the near future.

Concerning the presentation, McReynolds said, "I believe the information it contains is a good representation of the county and the many dedicated and talented team members serving its citizens. The presentation played a major role in communicating the many reasons York County is deserving of a AAA bond rating. I hope all citizens will take the time to review it once it is posted."

On January 29, York County successfully refinanced \$9,500,000 of lease revenue bonds resulting in over \$811,000 in savings. The savings were initially estimated at approximately \$600,000, however, the higher ratings and a positive market contributed to the better performance.


