VACo advocates for a state budget



VACo members agreed. We are heading into uncharted territory.

More than 160 callers participated in a conference call on May 29 to discuss the state budget impasse. The prevailing sentiment was if state legislators do not pass a budget before July 1, the consequences would be significant.

VACo Executive Director Jim Campbell urged members to contact their <u>delegates</u> and <u>senators</u> immediately and insist they adopt a responsible budget. Campbell also suggested inviting legislators to a Board of Supervisors meeting to explain the impasse.

"VACo members should also contact the media and outline the potential impacts," Campbell said. "Some counties will have to raise taxes, cut core services and eliminate or furlough employees."

Campbell encouraged members to develop a contingency plan of services and send it to VACo. He offered a few initial questions that have to be answered.

- How will counties fund services?
- How and when will counties begin their determination of essential versus non-essential services?
- Will your county have enough reserves to fund services?
- Will your county have to re-advertise your tax rates based on lack of state funding?
- How and when will counties begin to notify employees and school personnel of temporary furloughs or layoffs?

Failure to adopt a state budget leaves county governments responsible to fund and support state mandated services entirely through local revenues generated by real property, personal property and local business taxes.

Counties will almost certainly have to revise their budgets, requiring additional hearings and meetings. This may also hold true for school boards. Will local tax rates need to be revised and re-advertised?

Also, many locally adopted budgets do not account for the projected \$300-\$350 million state revenue deficit in FY 2014. Campbell said that localities receive about 45 percent of state revenues.

"VACo will continue to push for an adoption of a state budget because our counties and citizens deserve better than political gamesmanship," Campbell said.

R. David Laurrell announces retirement

Rustburg, VA – After 19 years of distinguished leadership and service to the citizens of Campbell County, R. David Laurrell announced to the Board of Supervisors on May 20 his upcoming retirement from the County Administrator position this fall.

Hired September 1, 1995, Laurrell, who holds a Master's degree in Management - HR/Organizational Development and a Bachelor's degree in Management and Technology from the University of Maryland, led Campbell County with nearly four decades of leadership experience. He consistently supported efforts to enhance the County's vision of being the most professional, collaborative, value-driven locality in Virginia. His previous public sector work included Assistant County Administrator (1993 -1995), and Public Safety Director (1988-1993) for Franklin County, VA, and Chief of Fire Operations in Martin County, FL. Prior to entering public service he established and operated his own construction business for over ten years.

Laurrell's community-oriented efforts were demonstrated throughout the Commonwealth of Virginia in his service and participation. He is currently a board member for the United Way of Central Virginia; Region 2000 Regional Services Authority; Region 2000 Business and Economic Development Alliance; and Region 2000 Local Government Council.

He serves on the Virginia Association of Counties Compensation/Public Safety Committee, and previously served on the Public Safety, Finance, and General Government Committees. His previous service included the Lynchburg Regional Chamber of Commerce Board of Directors: Senior Executive Institute Advisory Committee, (as a graduate of the University of Virginia's Senior Executive Institute); Virginia Emergency Management Association - President (1994-1995); and, the Governor's State Emergency Medical Services Advisory Board. He is a member of the International City/County Managers Association (ICMA) and the Virginia Local Government Management Association, serving previously on the Strategic Planning and Professional Development Committees.


Locally, his success as a County Administrator is evident in his effectiveness in long-term strategic planning, his dedication to balancing fiscal responsibility and managed growth, and his commitment toward creating a high performance organization with a focus on organizational values and citizen service. He was instrumental in upgrading the County's technology platforms, working with the schools on implementing a long term school facilities improvement plan, increasing public safety services, and implementing employee-driven teams toward identifying methods of heightening productivity while decreasing costs.

In 2010 the County was awarded the statewide best achievement award by the Virginia Association of Counties for the organizational development initiatives that had been implemented in the County over his tenure.

Laurrell's governing philosophy and leadership strategies have centered on developing a local form of government that focuses on high performance and strategically prioritizing, years in advance, where County resources will be applied in order to maximize the effective use of taxpayer funds. This was coupled with a mindful and common sense approach to managing the business of the County in order to mitigate long term financial and planning issues for Campbell County in the midst of a recession, funding shortfalls, and increasing mandates from other levels of government. During his tenure, the County implemented an award-winning Public Safety Department, Enhanced 9-1-1 and consolidated emergency services communications system, the Department of Economic Development, a Youth, Adult and Community Services Department (focused on improving outcomes and reducing costs for state-mandated children's services as well as volunteerism), and a Geographic Information Systems (GIS) Office.

Laurrell strongly believes in the value of regional collaboration and the fiscal benefits to area taxpayers. He played an integral role in establishing the area's Regional Services Authority and implementing the Regional Jail Authority, both of which have saved millions of dollars in taxpayer expense. He provided guidance and support to Region 2000 initiatives and helped to consolidate several entities under the Region 2000 Partnership umbrella. He always worked hand-in-hand with the Campbell County School System and the Towns of Brookneal and Altavista on a regular basis to help promote the prosperity of the County as a whole, and support the readiness of local youth for the years ahead. He recognized that the success of everyone was in the best interest of the County as a whole.

"The benefit Campbell County has



gleaned from David's leadership and expertise is immeasurable," said Eddie Gunter, Jr., Board of Supervisors member for the Concord Election District and longest serving member on the current Board. "He has moved the County forward while working with the Board to promote fiscal responsibility and provide quality services for citizens. His positive impact on Campbell County will be felt for many years to come. He will be truly missed."

"David embodies what it means to be a public servant," said J.D. Puckett, Board of Supervisors member for the Brookneal Election District and current Board Chairman. "His commitment to governing with vision, maintaining sound government practices and upholding democracy indicate his dedication to providing the best options for local citizens...he has always had their best interests at heart."

Laurrell's departure from official service is bittersweet, having made Campbell County his permanent home for nearly two decades. "This was a very difficult decision for me to make. However, I think the timing is best for me as well as the County in order to prepare for the future. The opportunities that were afforded me were incredible and I will be forever grateful for that. The hardest part is leaving behind many of the great friendships and relationships that have developed over the years. I have great respect for the Boards and people I have worked with over the

Loudoun County again recognized as a 'Fit-Friendly' organization

The Loudoun County Government has been recognized as a "Fit-Friendly Worksite" by the American Heart Association for the seventh consecutive year. The county has received the group's Platinum Award – the highest level of achievement.

The Fit-Friendly Worksite Program recognizes employers who champion the health of their employees by promoting a culture of wellness, implementing physical activity and nutrition programs and demonstrating measurable outcomes related to workplace wellness through behavior change and cost savings.

According to the American Heart Association, U.S. employers lose an estimated \$225.8 billion a year because of healthcare expenses and health-related

losses in productivity. Lack of regular physical activity raises the risk for a host of medical problems, such as obesity, high blood pressure and diabetes. Studies suggest that implementing a worksite physical activity program and promoting a culture of activity can help employers increase productivity, reduce absenteeism, lower turnover and reduce healthcare costs.

"Loudoun County's wellness and health improvement strategy has led to higher employee engagement, significantly lower health risks and medical savings in excess of \$1.8 million since 2005," said County Administrator Tim Hemstreet. "Physical activity and employee wellness are important priorities for our organization, and we encourage all Loudoun County employees to participate in our wellness activities."

Almost three-fifths of respondents said procurement fraud occurred during vendor selection and almost half noted that fraud occurred in the invitation to present a quote.

The study found that asset misappropriation is by far the most common economic crime with 69 percent of respondents suffering from it.

Schemes can be as simple as employees stealing inventory or thefts being covered up by marking good inventory as "scrap" and reselling it.

Visit Tazewell County and The Coal Miners' Memorial

The Coal Miners' Memorial is a testament to the heritage of the Town of Richlands. Created of black granite, the front wall represents the mine. Cascading water covering the entrance is reminiscent of the abundant coal resources and wealth flowing from Mother Earth. Etchings of the history of mining linger on the face of the mine, while the back wall bears the names of almost 1,100 miners from the surrounding counties who died in mine-related accidents. Wearing the toil of the day, the miner with his lunch bucket and pick in hand catches a breath of fresh air as he exits the mine. The engraved brick walkway is a lighted path as he continues his trek home. Dedicated on May 17, 2003, the memorial stands as a tribute to the men and women who sacrificed all, and those who continue to make sacrifices to earn a living in the mining industry.

A meandering waterfall depicting the natural landscape that cradles the mines in Southwest Virginia, completed in the summer of 2006,



complements the monument. The stepping stone waterfall is representative of the rugged terrain that captures the beauty of the mountains which surround the region. Coal mining is our way of life, our history, our heritage and our pride.

Mason Neck State Park honored

Governor Terry McAuliffe and First Lady Dorothy McAuliffe joined Virginia park-goers to celebrate Mason Neck State Park's designation as one of "America's Favorite Parks" as part of the Coca-Cola Company's America Is Your Park campaign. The Governor and First Lady also launched a new outdoor challenge at Mason Neck to encourage visitors to enjoy their stay at the park and get active at the same time. Coca-Cola awarded Mason Neck the second-place prize, a \$50,000 recreation grant which will be used for the challenge that was launched today.

"Virginia's state parks are a tremendous economic asset for the Commonwealth and a great resource for Virginians who want to get outdoors and get active this summer. On behalf of the Commonwealth of Virginia, I want to thank Coca-Cola for supporting our parks and encouraging people to get active outdoors," said Governor McAuliffe. "Our thanks also go to those who voted for Mason Neck and particularly the Friends of Mason Neck State Park who organized a vigorous and successful get-out-the vote campaign."

Mason Neck earned more than 278,000 votes through the support of park-goers who helped the park finish second in Coca-Cola's America Is Your Park campaign by logging their daily fitness activities and rallying the local community to support the park. The first-place winner was Veteran's Memorial Park in Moore, Okla., which the city is rebuilding after the park was devastated by a tornado that hit the town last year.

We're now using that same technology to educate, entertain and inspire people about our natural and cultural treasures and showcase the fun, health and well being benefits of outdoor recreation. We're really fighting fire, with fire."

The Virginia State Park system is managed by DCR.

The recreational grant from Coca-Cola is just a first step in the development of the statewide outdoor challenge. The Virginia Association for Parks, a statewide nonprofit organization that supports state and national parks in Virginia, is undertaking a fundraising effort for visitor center displays across the state. 
Countdown to the Fairfax 2015 Games

Let the Games Begin! With 400 days to go until 12,000 public safety athletes kick-off the World Police and Fire Games, Fairfax 2015, the organizing committee for the Games, recently announced the establishment of its Honorary Board, new funding commitments totaling \$5 million from public and private sources, and its ceremonial venues for the Games.

The World Police and Fire Games are coming to the National Capital Region for ten full days of competition beginning June 26, 2015. The courage and competiveness of public safety (police, fire and other first responders) will be on-display at one of the largest multi-sport events in the world. Governor Terry McAuliffe announced he will chair the Games' Honorary Board. Other prominent national, regional and local leaders from the worlds of politics, business and sports have also joined Fairfax 2015 to serve as members of the organization's Honorary Board in support of next summer's World Police and Fire Games. (Full list of Honorary Board attached.)

Fairfax County tourism and hospitality officials project that Games visitors and activities will have a primary economic impact in the range of \$60 million to \$80 million. The budget to pull-off the massive 60 sport Olympic-style event is estimated at \$20 million according to Fairfax 2015 (www.fairfax2015.com).

New funding to support the effort has been secured from seven new official corporate partners and from Fairfax County, who recently approved \$2 million



At a press conference at Fairfax County Fire Station 42 near Wolf Trap National Park, site of the Closing Ceremonies on July 4-5 weekend next year, a contingent of public officials and business executives committed their time and resources to the Games.

"I am excited to serve as Chairman of these Fairfax 2015 Olympic-style games and to help support and honor the first responders and public safety heroes who have given of their service and sometimes their lives to protect us," said Governor Terry McAuliffe. "If there is one thing I have learned supporting law enforcement and fire organizations over my years in public service, it's that police officers, sheriffs' deputies and firefighters are intensely competitive. Fairfax 2015 will showcase these great athletes and offer a great boost to the Commonwealth's tourism industry. Virginia and Fairfax County are the perfect host for this event and we are ready to let the games begin."

Sharon Bulova, Chairman of the Fairfax County Board of Supervisors, welcomed attendees and said Games visitors are expected from over 70 countries and athletes will compete at 53 venues not only in Fairfax County but across the National Capital Region. She revealed that Reston Town Center will serve as the Athletes Village, RFK Stadium in Washington D.C. will be home to the opening ceremonies and that nearby Wolf Trap will be an ideal host to the closing ceremonies July 4 weekend. Delegates from the World Police & Fire Games Federation were in Fairfax last month to tour both ceremonial and competition venues. Competition venues are being secured and will soon be announced.

"Fairfax County is honored to host the Fairfax 2015 Games," said Bulova. "I am so proud of our public safety officers. In particular, thanks to Police Chief Edwin Roessler, Jr., Fire Chief Richard Bowers, Jr. and Sheriff Stacey Kincaid for working tirelessly behind the scenes to help plan and promote the Games as we draw closer to the event.

Jim Corcoran, president and CEO of the Fairfax County Chamber of Commerce, followed Bulova in committing business community support. "We believe these Games will showcase what is best about doing business here in Fairfax County," said Corcoran. "People know about our highly educated and well-trained workforce, major corporations who have chosen Fairfax for headquarters operations and our technology infrastructure."

"Today, we are talking about the quality of life in Fairfax County," he added. "We appreciate the Governor's business acumen as Honorary Chair. I want to stress Fairfax 2015 is also about economic development."

Local businesses and destinations will certainly benefit from Games visitors – hotels, restaurants, stores, shopping centers, service stations, movie theaters – you name it, the impact will be felt. Venues and competition hosts will also enjoy benefits including ice rinks, ball fields, bowling alleys and indoor arenas or fields. Historical landmarks will see admission fees.

Fairfax 2015 also unveiled a list of seven corporate sponsors who have committed over \$2 million to date. This includes Keolis, Pierce, SAIC, Scott Safety, Cardinal Bank, Cordia Partners, and Venable. Rockville-based Keolis America operates the Virginia Railway Express. "As a world leader in passenger rail and transit, Keolis understands and appreciates the vital role that first responders play to ensure the safety of our customers and the community in an emergency situation," said Steve H. Townsend, CEO of Keolis America. "Speaking on behalf of the more than 4,500 Keolis employees in North America, we are pleased and honored to pay tribute to these brave men and women by becoming a major sponsor of the Fairfax 2015 World Police & Fire Games."

Bill Knight, CEO of Fairfax 2015, who has executive experience with the Summer Olympics in Atlanta, World Cup USA and other major events also spoke at the press event. "We are making great progress in the planning and coordination of the Games which are 400 days from today," he said. "The days will fly-by, so it is critical that individual citizens and business leaders step-up today, embrace the World Police and Fire Games and help accelerate the momentum we are currently enjoying. Whether joining the effort as a sponsor, a volunteer, a member of our merchant program or simply a fan, these Games will be an amazing experience for this region and our communities."

County bond ratings affirmed



James City County is one of many Virginia counties that has had its bond rating affirmed. Standards and Poor (S&P) Rating Services has affirmed James City County's AAA and AA+ bond rating for its general obligation and appropriation-backed obligations for the next two years. The rating also includes the County's Economic Development Authority and, according to S&P, reflects the County's strong general credit characteristics, commitment to repay appropriation-backed obligations and strong contractual provisions that include an absolute and unconditional payment provision upon annual appropriation.

S&P noted the following credit factors in its rating evaluation:

- A strong Hampton Roads local economy.
- The County's budget flexibility and availability of reserves.
- An adequate FY 2013 budget performance showing a general fund surplus of \$1.9 million with a 3.3 percent deficit in expenditures.
- Very strong liquidity, with available cash and equivalents and short-term investments.
- Very strong management conditions, with strong policies and practices in place.
- An adequate debt and contingent liability profile.

"We are extremely pleased to have our AAA bond rating reaffirmed. This is a positive result of great team work with the Board of Supervisors placing high standards on conservative budgeting and fiscal responsibility combined with a very dedicated and capable staff working hard to achieve those goals and objectives," says Mary Jones, Chair of the Board of Supervisors.

The future appears stable as well. S&P noted, "The stable outlook reflects our view of James City County's long history of strong and proactive management and maintenance of a strong financial position. Therefore, we do not expect to change the rating within the two-year outlook horizon."
