# Governor Takes Final Actions on Remaining Bills from 2024 Regular Session



On Friday, May 17, Governor Youngkin announced his final actions on the 55 bills that were returned to him by the legislature after consideration of his amendments at the April 17 reconvened session. The Governor had thirty days to take final action on these bills; at this stage in the legislative process, the Governor may sign or veto bills, or take no action, in which case a bill takes effect without his signature. Governor Youngkin signed seven bills, including legislation that allows additional local authority to reduce speed limits, as discussed below, and vetoed 48 bills.

Of interest to local governments are the following actions on bills:

#### Legislation Signed Into Law by the Governor:

**Local authority to reduce speed limits:** <u>HB 1071 (Carr)</u> allows any locality to reduce the speed limit to less than 25 miles per hour (but not less than 15 miles per hour) on highways within its boundary that are located within a business or residence district, provided that signage and notice requirements are met. VACo has historically supported this concept and advocated for passage of HB 1071.

### Legislation Vetoed by the Governor:

**Teacher salaries:** <u>HB 187 (Clark)/SB 104 (Lucas)</u>, as passed by the General Assembly, would have required the state to provide its share of salary increases over the next three legislative sessions sufficient to raise the average teacher salary in Virginia to at least the national average teacher salary by the end of the next biennium, with the increases phased in at increments specified in the bill. The Governor's amendments, which were rejected by the General Assembly in April, would have modified the bills to require an annual review of teacher compensation (rather than the current biennial review), and required the budget bills introduced in the next two sessions to propose funding for compensation

incentives for Standards of Quality-funded instructional and support position salaries to remain competitive (at or above the national average). In his veto message, the Governor expressed concern about the bills' proposed methodology and potential to limit future flexibility in developing budgets.

#### K-12 funding for At-Risk Program and English language learners: <u>HB 624 (Rasoul)</u>/<u>SB 105</u>

**(Lucas)** would have revised the At-Risk Add-On program to create a new At-Risk program and funding formula and required staffing for English language learners to be based on student proficiency levels, as well as revising the National Teacher Certification Incentive Program. The bills also would have directed the Department of Education to collect data on English language learner expenditures and student proficiency levels, and to develop a plan for revised special education staffing requirements that would address needs in each school division. The Governor had proposed to add a reenactment clause and direct the Department of Education to collaborate with the Joint Subcommittee on Elementary and Secondary Education Funding to determine the impact of modifying the proxy used to estimate the number of at-risk students, as well as the impact of eliminating the Standards of Quality Prevention, Intervention, and Remediation program. In his veto message, the Governor reiterated his interest in further review of the K-12 funding structure.

**Skill games:** <u>SB 212 (Rouse)</u> would have established a regulatory and tax framework for skill games, as defined in the bill. The Governor's April amendments proposed significant changes to the legislation, including increasing the tax rate, allowing local governing bodies to hold referenda to prohibit electronic gaming devices (as defined in the bill) within a locality, revising the distribution of tax revenues, and barring electronic gaming devices within certain distances of casino gaming establishments, horse racetracks or satellite facilities, or schools, child day centers, or religious institutions. In the Governor's veto message, he cited the need for "a robust set of safeguards" for expanded gaming options, but also indicated a willingness to work with the legislature on the issue; additional legislation on skill games is expected to be considered as part of the special session that convened last week.

**Recordation and property tax exemptions:** <u>HB 568 (Askew)/SB 517 (Williams Graves)</u> would have eliminated the recordation tax exemption for the Virginia Division of the United Daughters of the Confederacy and eliminated the real and personal property tax exemption for this group and several other entities. The Governor's April amendments would have required a broader study of the effects of existing recordation tax exemptions and property tax exemptions that were granted by designation prior to 1971 and added reenactment clauses to the bills; his veto message explains that property tax exemptions previously granted by General Assembly designation are "ripe for reform," which should, in his view, "involve broad-based measures, allowing local governments autonomy in determining tax exemptions and considering the locality's tax base and deed transfers."

Chesterfield County Partners With Gelati Celesti to Develop Official 275th Anniversary Ice Cream Flavor



Together, the group decided on "Chesterfield Honey Bear Tracks."



# VACo Kicks Off Regional Meetings In Prince George County



Thank you Senator Lashrecse Aird and Delegate Carrie Coyner for speaking at the Regions 1 & 4 meeting! VACo staff is back on the road this year visiting counties among the <u>13 VACo regions</u> defined across the Commonwealth. VACo will hold eight regional meetings this year, five in person and three virtually. The first regional meeting was held on May 3 in Prince George County, where counties from VACo regions 1 and 4 met at the Commonwealth Center for Advanced Manufacturing. Region 1 encompasses the counties of Accomack, Charles City, Isle of Wight, New Kent, Northampton, Prince George, Southampton, Surry and Sussex, while Region 4 contains the counties of Amelia, Brunswick, Charlotte, Dinwiddie, Greensville, Lunenburg, Mecklenburg, Nottoway, and Prince Edward. These regional meetings allow VACo staff to hear directly from county staff and elected officials on the important issues facing localities across Virginia. They also help VACo staff craft the legislative program for the upcoming 2025 legislative session.

VACo was pleased to be joined by Senator Lashrecse Aird, Delegate Carrie Coyner, Delegate Kim Taylor and Delegate Otto Wachsmann, as well as Senator Emily Jordan's Chief of Staff. The meeting began with legislators who represent the regions speaking about their priorities and insights about the region they represent. Senator Aird began by reiterating the importance of a timely resolution of the budget process as this funding would be crucial for all localities, especially more rural ones as local governments are discussing their budgets. Top priorities for the Senator include mental health funding and access, healthcare costs generally, and supporting economic development so business in the Commonwealth can retain workers as well as attract business from out of state. Delegate Coyner focused primarily on education issues and touted some recent successes in legislation she carried, notably **HB 1087** and **HB 1089**, which relate to dual enrollment and special education, and were signed into law this year. Delegate Taylor spoke about how her district is primarily rural and how she is always focused on issues that affect rural localities. Delegate Wachmann would close out the legislators' discussion segment with issues he is focusing on, such as rural healthcare, correctional facility funding, and acquiring funding to compensate localities that house state prisons for their costs involved in providing public safety and other services to these facilities.

Thank you Delegate Kim Taylor and Delegate Otto Wachsmann for speaking at the Regions 1 & 4 meeting!

After the legislators discussed their thoughts, representatives from each county outlined the top issues or legislative priorities in their locality. Several issues emerged as common areas of concern. including local authority, school funding, jail operations, transportation and workforce and economic development. Local authority, like at most VACo meetings, was a major discussion topic. Emphasizing local authority for land use decisions including housing, short term rentals and solar siting is and has always been a priority for VACo. VACo staff reaffirmed this commitment during the meeting while listening to why county leaders find this authority so important to county governance. School funding was discussed often and many of the counties in attendance relayed their continued support for sufficient funding and the option for more funding streams that would help localities address inadequate school facilities like the **legislation** that would have expanded the authority to impose an additional sales tax after approval in a referendum, which passed the General Assembly this year, but was vetoed. County leaders broadly hope to see per diem jail rates raised, and discussed how transportation needs outweigh available resources, especially on primary and secondary roads. Lastly, while the regions have touted recent economic successes there is always room for improvement. Localities in the regions hope there will be more state support for economic development in the region, as well as further workforce development initiatives, possibly through community college and skills training programs. During the conversation, one county representative shared an example of local efforts to promote economic development in the region. There was an instance of a local chicken plant shutting down last year and county leaders stated that to serve the interest of the region they had to look past county lines. In this instance, counties worked together to create a poultry growers' co-op in place of the aforementioned plant that would save jobs. This is an excellent story of counties coming together for the best interest of their citizens and solving a problem by thinking regionally.

VACo is grateful to the regional members, General Assembly representatives, and business partners who participated in the meeting. VACo would like especially to thank Prince George County and the staff at the Commonwealth Center for Advanced Manufacturing for discussing and sharing their wonderful facility with us.

# VACo and The Chesapeake Bay Program Soliciting County Leader Input



# Chesapeake Bay Program Science. Restoration. Partnership.

# **SMART SCALE Applications Open June 1**

Virginia's premier transportation funding program, SMART SCALE, will be accepting full applications starting on June 1, 2024. SMART SCALE is the method of scoring and funding transportation projects that meet one or more transportation needs identified in Virginia's Transportation Plan, <u>VTrans</u>. This will be the 6<sup>th</sup> Round of the SMART SCALE process.

**VACo previously reported**, in December 2023 the changes made to SMART SCALE that would be in effect for Round 6. Since this article was published, The Commonwealth Transportation Board (CTB) has adjusted the scoring metrics in the following way:

On December 4<sup>th</sup>, 2023, the CTB voted to remove "land use" as a factor to considered when scoring SMART SCALE applications. At the January 16<sup>th</sup>, 2024 meeting of the CTB, the <u>board passed a</u> <u>resolution</u> stating, "... upon further consideration, the Board has determined that it is necessary for a Transportation Efficient Land Use factor to be utilized in the SMART SCALE Prioritization Process." The resolution would continue, "... the Commonwealth Transportation Board hereby updates the SMART SCALE Prioritization Policy adopted on December 4, 2023, by adding the Transportation Efficient Land Use factor and adopting the OIPI staff recommendation of including the Transportation Efficient Land Use factor as a multiplier to be utilized in the SMART SCALE Prioritization Process, as set out below," with an attached graphic to show the new SMART SCALE factor weighting that determines the project's score (found below) :

Factor	Safety	Congestion Mitigation	Accessibility	Economic Development	Environmental Quality	Land Use
Category A	15%	45%	25%	5%	10%	Up to 100% Added
Category B	20%	25%	25%	20%	10%	
Category C	30%	20%	15%	25%	10%	
Category D	40%	10%	10%	30%	10%	

The land use scoring factor is unlike the other five factors in that it serves as a multiplier to enhance the project's overall score.

## For Those Who Serve Virginia: VOLSAP Helps Volunteers Save



Every day, volunteer firefighters and rescue squad workers save lives and protect property in communities across Virginia. While they serve others, VOLSAP can help first responders save for the future.

VOLSAP, the Virginia Volunteer Firefighters' & Rescue Squad Workers' Service Award Program, is an optional savings plan that can be used as part of your locality's strategy to recruit and retain volunteers.

#### How Volunteers Can Save With VOLSAP

- Eligible volunteers submit the application form and have it certified by their local squad or department to become a VOLSAP member.
- Volunteers contribute money quarterly, and a representative from the department or squad submits the contributions on their behalf.
- To encourage saving, a department, squad or local government may elect to make the contributions on behalf of members or match a portion of the amount members contribute.
- Contributions are invested alongside the Virginia Retirement System (VRS) pension trust fund in a widely diversified portfolio.
- When members reach age 60 with at least five years of qualifying service, they are eligible to receive a distribution that includes any investment returns and matching funds.



## You are VAcorp



You are not merely a customer of VAcorp; you *are* VAcorp! We are both owned and governed by you – our members! VAcorp is created under 15.2-2700 of the local government code where all assets and surplus belong to the members. In addition, VAcorp is controlled by a Supervisory Board that is elected from and by our members. The Board determines and approves all major risk pool decisions, and as a voting member, you have a voice in the decisions that matter most.

#### Know Who You Are

Because you are VAcorp itself, we think it is critical that you understand exactly what VAcorp is and why it exists. Many simply think of us as their "insurance carrier" – writing customized coverages and handling claims when they occur – but we are so much more!

## **Our History**

#### The Birth of Risk Pools

VAcorp is not an insurance company, but rather a Risk Pool.

Unstable economic conditions in the mid-1980s led to a commercial insurance crisis with ballooning premiums and widespread policy cancellations. As a result, Risk Pools began to form as an alternative to volatile traditional carriers, allowing Pool members to exert more control over their coverages and costs. Today, almost all public sector entities throughout the country get their coverage from Risk Pools rather than from commercial insurance companies.

#### VAcorp's Origin

VAcorp was founded by a handful of Virginia counties in 1993. The ultimate goals of the program were to provide **cost stability**, the most **comprehensive coverages** possible, and **custom services** tailored specifically to the unique needs of our members. While we are pleased by how well our prices compare against the competition, our goal was never to guarantee the lowest cost. Instead, we promised to avoid the wild price swings that we've seen in other providers and provide stable pricing year after year, and that is exactly what we have delivered. VAcorp rates are actually **lower today in 2024 than they were in 1993!** 

#### VAcorp's Growth

Today, VAcorp is the **largest self-insurance risk pool** for public sector entities in the Commonwealth with a membership retention rate of better than 98%. Over the years, we have expanded beyond counties to include municipalities, school divisions, authorities, volunteer fire & rescue companies, state agencies, and non-profits funded by taxpayer dollars. **Over 560 members** have joined VAcorp, including 8 of the 10 largest counties, 8 of the 10 largest cities, and 8 of the 10 largest school divisions. We believe that the extraordinary success of the program can be attributed to our unwavering commitment to our founding principles.

## **VAcorp Exists to Serve You**

VAcorp was created solely to serve Virginia's public sector entities, and from day one until now, we have never lost sight of that purpose. Because we answer only to our members, every decision is designed to benefit the group over the long haul.

VAcorp advocates for local government through a myriad of partnerships with affiliated associations including: VACo, VSBA, VLGMA, VASS, VFGOA, VASBO, LGA, Regional Jail Association, PDC, etc. While there is a cost associated with these partnerships, they add value to the group by aiding in our ability to lobby the General Assembly on behalf of our members.

You may not always see the immediate payoff, but every VAcorp decision is made in alignment with our vision to serve our members and promote the health and longevity of your program.

Take a look at a few of VAcorp's milestones over the years:

- **1993** VAcorp is established with 12 founding members and less than \$700,000 in annual contribution.
- **1998** VAcorp terminates service contract with claims administration vendor and hires staff to promote more control and efficiency.
- **1999** VAcorp offers coverage to K-12 Public Schools across the Commonwealth.
- **2001** VAcorp begins offering Public Officials Liability coverage in response to VArisk offering limited coverage.
- **2004** VAcorp begins providing Environmental Liability coverage to all members at no additional cost. Even in 2024, VAcorp is the only provider offering this coverage with a low \$25,000 deductible. Other providers offer this coverage with a \$250,000 deductible.
- **2008** VAcorp responded to the great recession by freezing rates and providing financial relief with over \$8,000,000 in dividends to members.
- **2011** VAcorp introduces Line of Duty Act (LODA) coverage, creates the only LODA trust in the state, and absorbs existing LODA losses in response to the state pushing this cost to the local level. VAcorp paid all of its members 2010 past liability for over \$1,000,000.
- **2013** VAcorp merges with the VSBA Self-Insurance Group and assumes their liabilities to prevent School Boards from being assessed. This action saves Local Governments in excess of \$5,000,000.
- **2013** VAcorp becomes the first to offer Cyber Risk coverage in Virginia offering the broadest coverage available to local governments anywhere in the US.
- **2016** VAcorp offers Student Accident and Catastrophic Accident coverage in order to fill VHSL coverage gaps.
- 2020 VAcorp provides over \$5,000,000 in rate credits during the COVID pandemic to assist members.
- **2023** VAcorp includes security risk management coverage (active shooter) for all members (coverage has been included for Schools since 2013).
