- Reviews plans for general conformance with the USBC, federal and state laws, and local ordinances;
- Makes interpretations of the building, electrical, plumbing and mechanical code requirements that define approved system installations;
- Prepares plan review documents outlining code deficiencies identified during plan review;
- Provides customer service to the general public, internal customers, and outside agencies; answers questions related to the code;
- Supports the inspectors by assuring that the approved construction documents are ready for use in the field:
- Acts as liaison between the division, general contractors, trade contractors, and property owners;
- Serves as a technical assistant to the County Building Official;
- Performs technical inspections of residential and commercial/industrial structures for compliance as needed;
- Prepare court documents and testify as needed;
- Participates in code related organizations to communicate and to be involved in the code change process;
- Determines compliance with handicapped accessibility standards for new construction and existing buildings and structures per building code requirements;
- Works with State and local Fire Marshal's offices with plan reviews;
- Participates in the Project Evaluation Committee;
- Responsible for the maintenance, care and cleanliness of all vehicles assigned to you;
- Performs other duties as assigned.

Qualifications:

- Education: Requires a high school diploma or G.E.D., plus additional training or course work in construction related programs;
- Experience: Requires three (3) years of experience and general knowledge in at least one building trade or construction related field;

- Complete the core module training and be certified as a Residential Building Plans Examiner within 18 months after date of employment;
- Continue training in trades and specialty areas as directed by Building Official and Department Head:
- Desired: Experience as a Plan Reviewer, Inspector, erosion and sediment control inspector with state certifications;
- Desired: Additional college level work in CAD, Engineering, Building Codes and/or Building trades highly preferred.

Core Skill Sets:

- Working knowledge of building codes and building construction techniques/methods and the ability to apply this knowledge in the analysis and interpretation of construction plans and specifications;
- Working knowledge of Campbell County Codes and utilization of County Code Book;
- Ability to comprehend and interpret blueprints and building plans and recommend corrective measures for inadequacies in planned or existing structures;
- Ability to interpret and enforce building codes firmly and tactfully and to establish and maintain
 effective working relationships with contractors, architects, property owners, co-workers and the
 public;
- Ability to physically be able to climb stairs or crawl in low or confined areas for the purpose of making inspections without assistance;
- Must have a legible handwriting;
- Must attend all mandatory code training and code change update seminars to remain certified;
