2024 VACo Achievement Award Entry:

Mental Health is Ageless- Chesterfield County

Executive Summary:

Chesterfield County Government, in partnership with the Chesterfield Suicide

Awareness and Prevention Coalition, developed a multifaceted *Mental Health is Ageless* campaign designed to increase awareness of how to recognize and respond to signs that an older adult may be having thoughts of suicide and to promote positive mental health in older adults through connection to others, meaningful activities, and resources. The creation of this older adult focused suicide prevention campaign filled a gap in suicide prevention campaign messaging focused on older adults, their family members, and their health care providers.

Highlights of the reach of our campaign include:

- *Mental Health is Ageless* social media posts resulted in 13,442 impressions, a reach of 10,547 and 543 engagements.
- 178 Webpage pageviews
- Local radio ad reach of 126,400, with a frequency of 3.8, resulting in 482,400 gross impressions.
- Chesterfield Unplugged Podcast generated 200 views/listens
- 48 resource packets mailed to primary care providers.
- 4 presentations to professional groups that serve older adults
- 3 presentations to older adults
- 1000 American Foundation for Suicide Prevention's Senior and Suicide Brochures disseminated through partner organizations and at community events

The Challenge:

September is recognized internationally as Suicide Prevention month. According to the Center For Disease Control people ages 85 and older had the highest rates of suicide in 2022 followed by people ages 75-84. In Virginia in 2021, people ages 75-84 had the highest rates of suicide (21.6 per 100,000), exceeding the national average (18.4 per 100,000). Based on this data, our planning group decided to focus on suicide in older adults for our September 2023 Suicide Prevention campaign. Results of focus groups conducted early in our planning process indicated that many older adults and those that care about or for them consider depression to be a standard and expectable part of aging. Additionally, older adult focus group participants indicated that they were not very comfortable talking about mental health. They stated that if they did so they would talk to their adult child or their primary care provider. Our campaign planning group was not able to identify a comprehensive suicide prevention campaign focused on older adults, their family members, and their health care providers.

Description of the Program

Chesterfield County Government and the Chesterfield Suicide Awareness and Prevention developed and implemented a multi-faceted *Mental Health is Ageless* campaign focused on three primary messages. These messages are:

- Depression and suicide are not a standard part of aging. It is important to be aware of signs of mental health concerns and connect to help if needed.
- Being involved in meaningful recreational, creative, and social activities contributes to positive mental health.
- You are not alone if you are struggling with your mental health. Reach out for help. Resources are available.

Campaign strategies included:

• Three Mental Health is Ageless videos, featuring older adults who live in Chesterfield telling the stories of what helps them maintain positive mental health and professionals in Chesterfield talking about strategies and resources. While the focus of our campaign was on positive mental health and encouraging help seeking behavior, we also felt it was important to provide information about mental health resources and other resources for older adults in our community Therefore, each video ended with the following image.

Chesterfield County and Chesterfield Suicide Awareness and Prevention Coalition's *Mental Health Is Ageless* campaign is an outstanding example of an initiative that promotes intergovernmental and cross-sector cooperation and coordination to meet a gap in available resources. The Chesterfield Suicide Awareness and Prevention Coalition is led by a Chesterfield County Mental Health Support Services Program manager and includes representatives from Chesterfield-Colonial Heights Social Services, Chesterfield County Public Schools, eight non-profit organizations, two faith-based organizations and two concerned citizens. Chesterfield County Constituent and Media Services, Chesterfield Community Engagement and Resources, Chesterfield County Public Library and Chesterfield County Information Systems Technology all contributed to development and/or implementation of the *Resilient Chesterfield* campaign. The Capital Area Agency on Aging was an essential part of campaign development and dissemination.

The Results of the Program:

Chesterfield County and the Chesterfield Suicide Awareness and Prevention Coalition achieved our goal of developing and implementing a comprehensive suicide prevention campaign focused on older adults, their family members, and their health care providers.

Worthiness of Award:

The *Mental Health Is Ageless* campaign reached over 136,000 people with a comprehensive suicide prevention campaign focused on older adults, their family members, and their health care providers. The creation of this resilience focused suicide prevention campaign filled a gap in suicide prevention campaign efforts focused on decreasing suicide in older adults, the age group with highest rates of suicide in both the United States and Virginia. *Mental Health Is Ageless* Campaign materials have been used in a variety of settings since Suicide Prevention Month in September 2023 and will be used in future campaigns, including Mental Health Month in May 2022.

The 2022 suicide data released by the CDC in August 2023 indicated that people ages 85 and older had the highest rates of suicide (22.4 per 100,00) followed by people ages 75-84 (19.6 per 100,000). In Virginia in 2021, people ages 75-84 had the highest rates of suicide (21.6 per 100,000), exceeding the national average (18.4 per 100,000).
