GENERAL OVERVIEW

The VACo Achievement Awards is a free competitive awards program open to local government members of the association. This annual competition recognizes local government programs that exemplify innovation, that can be replicated in other localities, and that partner and collaborate with local governments, private enterprises, or state and federal governments. We encourage all County departments to apply! Entry deadline is July 1, 2024.

ELIGIBILITY

All local government members of the Virginia Association of Counties may participate. There is no limit to the number of applications a County may submit.

All applications must comply with the following standards:

- 1. The program must have become operational before January 1, 2024, and remains operational.
- 2. Local government officials and/or staff must have played a significant role in developing and implementing the program, with only limited assistance from outside experts and/or consultants.
- 3. All steps in the application must be completed.
- 4. Awards will be given to departments or units, not individuals.
- 5. Programs that have received a previous VACo Achievement Award are ineligible.
- 6. The program must meet one or more of the criteria outlined below and must be signed by the county administrator or deputy/assistant county administrator, or department director.

CRITERIA FOR SELECTION

The nominated program must meet one or more of the following criteria:

- 1. Offer an innovative solution to a problem, situation or delivery of services.
- 2. Promote intergovernmental cooperation and/or cooperation with local, state and federal entities and/or a private enterprise in addressing a problem or situation.
- 3. Provide a model that other local governments may learn from or implement in their own localities.
- 4. Programs may be based on programs from another public or private entity but must represent innovative approaches or customization by the local government.

RULES OF ENTRY

- 1. All entries must be submitted in electronic format ~ PDF or WORD document. Email the electronic entry to gharter@vaco.org. Please include application form (Page 3).
- 2. Entries must be typed and double-spaced. Limit entries to 12 pages. State the problem, challenge or situation faced by the locality and how the program fulfilled the awards criteria (innovation, partnering or collaboration and a model for other localities). Tell how the program was carried out, including financing and staffing, and the program's results.
- 3. Include an executive summary of the program (no more than one page double-spaced) that can be used as a quick reference guide for judges and that can be used for press releases, brochures, etc.

JUDGING

Entries will be judged by a three-member panel selected for its expertise in County government. One entry will be selected as "Best Achievement" and will be honored as the top program for the given year. Best Small County and Best Large County programs will also be recognized.

AWARD PRESENTATION

The VACo Team will attend Board of Supervisors meetings to present award plaques. The top three winning programs also will be recognized at VACo's Annual Conference held on November 10-12, 2024. Winners will receive a special ribbon to be worn on their nametags, and will be recognized on the VACo website and in a news release sent to statewide media.

All entries must be dated no later than July 1, 2024, and emailed to Gage Harter at gharter@vaco.org.

Problem, challenge or situation faced by the locality

All small businesses require aptitude and support around essential topics such as finance and marketing to thrive. Whether a business is creating cutting edge technology, baking pastries, or providing consulting services, it cannot thrive if it cannot effectively bring in enough revenue to pay bills, or has a great concept that no one knows exists. While information is universal, the experience in accessing and engaging support for those topic areas varies greatly, particularly for minority-owned businesses. This disparity is not unique to Loudoun, but with the rapid rate of growth of Loudoun's population, and the ongoing impacts created by the COVID-19 pandemic for all small businesses, Loudoun has a greater opportunity to serve its small businesses and uniquely address the needs of its minority-owned businesses.

"We created Launch Loudoun as a coordinated program of tools and services designed to support entrepreneurs and our small businesses," said Buddy Rizer, Loudoun Economic Development Executive Director. "Each business is unique, and their needs vary, so it is our mission to provide personal experiences relevant to each situation. This program will help ensure that entrepreneurs have the resources and support they need to achieve long-term #LoudounPossible success."

Since its inception in May 2023, Launch Loudoun, has had a significant impact on furthering economic development within the community. One tangible outcome is the expansion of DED's small business team, with the addition of two new positions focused on small and minority-owned businesses. This growth demonstrates the program's success in scaling resources to meet the increasing demand for support services among entrepreneurs and small businesses.

In one year, Launch Loudoun has directly assisted 94 small businesses, providing them with valuable resources, guidance, and support to navigate challenges and drive growth. These businesses span

various industries and stages of development, from startups to established enterprises, contributing to job creation, innovation, and economic diversification within the county.

Additionally, the program's signature events, such as the Small Business Summit and Innovation Challenge, counseling hours, and work sessions have attracted over 1,600 attendees, fostering networking opportunities, knowledge sharing, and collaboration among entrepreneurs, investors, and stakeholders. This engagement not only enhances the visibility and reputation of Loudoun County as a hub for entrepreneurship but also facilitates the exchange of ideas and best practices, driving ongoing innovation and economic vitality.

Launch Loudoun's impact extends beyond quantitative metrics to include intangible outcomes such as increased community engagement, collaboration, and entrepreneurial spirit. By nurturing a supportive ecosystem for startups and small businesses, the program fosters a culture of innovation and resilience within the community, positioning Loudoun County as a dynamic and strategic destination for entrepreneurs and investors alike.

Standing up a new signature program is never a seamless process. Launch Loudoun faced several obstacles typical of initiating a new initiative. Key challenges included establishing the program framework, securing funding, and hiring the right staff to drive the initiative.

One primary barrier was the extensive planning and approval process required to start a new program. This included obtaining buy-in from various stakeholders and navigating processes to secure necessary funding. To overcome these hurdles, Loudoun DED engaged in thorough planning and frequent communication with local government officials, ensuring transparency and alignment with broader economic development goals while also leveraging existing relationships with community partners to garner support and streamline approvals.

Hiring staff for the initiative posed another significant challenge. Identifying and recruiting individuals with the right mix of expertise in small business development, economic policy, and community outreach was critical but time-consuming. To address this, Loudoun DED implemented a rigorous recruitment process to attract top talent. The hiring team prioritized individuals with a deep understanding of the local business landscape and a commitment to community development.

Establishing operational infrastructure for the new program was also demanding. This involved setting up office space, acquiring technology and resources, and developing program guidelines and materials.

These issues were tackled by creating detailed project plans and timelines, allowing for efficient resource allocation and task management.

Through strategic planning, stakeholder engagement, and a robust recruitment process, we successfully launched Launch Loudoun, providing crucial support to small businesses and fostering local economic growth.

This initiative represents a departure from traditional economic development programs, which often have a one-size-fits-all approach. Launch Loudoun's emphasis on inclusivity and equity reflects a deep understanding of the unique needs and challenges faced by small and minority-owned businesses in

Loudoun, particularly in times of crisis. By prioritizing support for these businesses, and providing tailored events and programming, Launch Loudoun demonstrates a commitment to fostering a more inclusive, resilient, and diverse economic ecosystem.
