


Virginia Delegation Advocates for County Needs at NACo Annual Conference



Virginia counties made a strong showing at NACo's 2024 Annual Conference in Hillsborough County, Florida, with Virginia county leaders successfully advocating for policy changes in NACo's legislative platform, serving in leadership roles within the Association, participating in policy committee meetings and other conference sessions, and helping to shape NACo's future by voting on a slate of new officers.

Loudoun County Supervisor Juli Briskman brought her lived experience and the experience of her constituents to bear in advocating for enhancements to NACo's legislative platform language regarding childcare. Supervisor Briskman's amendments stressed the need for a mixed-delivery early childhood system that supports high-quality care and education and underscored the importance of childcare in enabling parents to stay in the workforce. She collaborated with Commissioner Erica Crawley from Franklin County, Ohio, to advocate for the enhancements, patiently working through the NACo policy committee process in order to submit the changes to the full NACo membership for approval. Supervisor Briskman told VACo that in her district, more than two thirds of women over the age of 16 are part of the labor force. "They struggle with reliable, affordable quality childcare, just like I did as a single head of household," Supervisor Briskman said, noting that Loudoun County is in need of approximately 1,700 childcare slots. She successfully advocated for Loudoun to use a portion of its ARPA dollars on several approaches to ameliorating this issue, and is working with the Loudoun County Chamber of Commerce on the connection between childcare and the workforce.

Virginia counties will have a human services champion at the helm of NACo's Health Policy Steering Committee with the appointment of Loudoun County Chair Phyllis Randall as the Chair of this body. Issues vital to the health of local communities, including mental and behavioral health services, long-term care, substance abuse prevention and treatment, and services for persons with developmental disabilities, fall within the jurisdiction of this Committee. Chair Randall brings extensive experience to her new role, having spent more than 20 years as a mental health therapist in addition to her strong advocacy for behavioral health throughout her time in public office. "It is an honor to have been chosen to lead the Health Committee for the National Association of Counties," Chair Randall told VACo. "Over the next year, we will take a holistic approach to discussing health and the way that county governments across this country can lead the charge on improving outcomes for our residents."

VACo's representative to the NACo Board is Lancaster County Supervisor and Immediate Past President Jason Bellows. "Serving on the NACo Board of Directors is a privilege that allows me to directly impact federal policy decisions that improve our communities and enhance the lives of our residents," Bellows said. "There are many emergent issues from AI to affordable housing that are creating both challenges and opportunities for counties across the nation. NACo allows us to speak with one united voice on federal policy thereby amplifying our needs at the federal level."

VACo Executive Director Dean Lynch said, "VACo is fortunate to have Jason Bellows representing Virginia counties at the national level. He brings a wealth of knowledge about county issues to his NACo service, and he works hard to keep his VACo colleagues informed about national issues."

VACo congratulates county members on their successful work at the national level and looks forward to a continued partnership with NACo.

Floyd County Hosts Regions 10 and 12 for Discussions on Agriculture, Transportation, Housing, and More

Floyd County hosted counties in Regions 10 and 12 on July 10 for a robust discussion of regional issues and priorities. The meeting began with welcoming remarks from Floyd County Chairman Joe Turman and Regional Directors Linda DeVito Kuchenbuch, Jerry Boothe, and Laura Walters. Virginia Department of Agriculture and Consumer Services Commissioner Joe Guthrie, a former local elected official as well as a sixth-generation family farmer, provided an overview of key issues in Virginia agriculture and major initiatives underway at the Department.

Agriculture remains Virginia's largest private industry, with an economic impact of \$82 billion annually. Top products include broilers, cattle and calves, and turkeys; soybeans are the state's largest export. Commissioner Guthrie discussed the Governor's work to support Controlled Environment Agriculture as an emerging industry, in addition to efforts to support agricultural practices that help Virginia to meet its Chesapeake Bay pollution reduction goals. Additional major initiatives in which VDACS is involved include hemp and cannabis regulation and enforcement; the establishment of a new Virginia Beer Distribution Company to support craft brewers; development of a market for blue catfish in order to limit the population of this invasive species; and consolidation of the VDACS Farmland Preservation Office with forestland preservation work in the Department of Forestry to create an Office of Working Lands Preservation, which will improve the state's capacity to support this function. VDACS also continues to monitor and respond to emerging animal diseases and invasive species.

VACo was honored to welcome Delegate Wendell Walker and Delegate Wren Williams, who shared their priorities for the upcoming session. Delegate Walker noted that energy would continue to be a



major area of focus, as well as broadband connectivity. He underscored the importance of providing adequate staff and funding to VDACS. Delegate Williams indicated that he would continue to focus on avoiding unfunded mandates, developing the infrastructure needed to support housing (water and sewer connections in particular), and improving rural health care. He discussed successful legislation he carried this session to allow localities to bill on behalf of a volunteer fire department to support a licensed EMS agency; the state's Division of Legislative Services has developed a model ordinance for localities that are interested in using this new authority. He encouraged attendees to contact him directly and to reach out ahead of the session in order to address needs with draft legislation or budget amendments.

VACo was also pleased to be joined by representatives from the offices of Senator Kaine and Representative Griffith, as well as Senator Hackworth and Senator Peake.

County representatives shared top areas of concern in a roundtable discussion. Common themes emerging from the discussion included the need for additional support for local EMS to address recruitment, retention, and new regulatory requirements; the need for additional transportation funding to support rural counties; and the importance of additional tools to generate school capital funding. Several county representatives discussed the critical need for housing options as a component of economic development, in addition to business site development. Several attendees expressed strong support for preserving local authority over decisions regarding siting of solar facilities. Several county representatives also highlighted pressures in Children's Services Act services as an area of concern. In addition to VACo's upcoming County Officials' Summit and Annual Conference, attendees were encouraged to attend the upcoming Governor's Summit on Rural Prosperity, which will be held October 29 and 30 in Wytheville.

VACo is grateful to our members, business partners, legislators and staff, Commissioner Guthrie, Floyd County, and the owners and staff at Chateau Morrisette for a productive and informative discussion.

Description: The building faces north and is a one story red colored brick and concrete structure. The building is located on landscaped grounds in the center of New Kent on the north side of the courthouse. The north front has a one story porch with four white colored columns. Behind the porch is a two story square brick tower with steep roof. The building extends east and has a hipped roof. The building houses the County Administration. Next to the building is the old red colored brick County Jail.

History: The county was created in 1654 and Brick House was selected as the county seat. The first courthouse was erected. In 1691, the county seat was moved to New Kent. The second courthouse built and was burned in 1787. The third courthouse was built and burned in 1864. The fifth courthouse was built in 1909 to 1910 and is still standing. The sixth courthouse was constructed in 1990 to 1992.

Allyson Williams appointed Wythe County PIO and Grant Coordinator


WYTHE COUNTY, Va.- Wythe County recently hired a new full-time Public Information Officer and Grant Coordinator.

RE: New Emergency Response Standard Proposal Comments - OSHA-2007-0073-0118

Dear Assistant Secretary Parker,

On behalf of the Virginia Association of Counties (VACo), I would like to thank you for the opportunity to comment on the proposed changes to the Occupational Safety and Health Administration (OSHA) Fire Brigades standard, 29 CFR 1910.156. Expanding these standards and potentially applying them to volunteer firefighters could create additional challenges for local governments and fire organizations already struggling to recruit and retain firefighters. While we understand the need to update the standards, we are concerned that the proposed changes, in their current form, could have a substantial impact and impose significant unfunded mandates on local fire organizations and governments.

These concerns include but are not limited to: potential increases in training and certification requirements for firefighters and officers, additional administrative tasks and documentation requirements, the need to budget for the purchase, maintenance, and replacement of firefighting apparatus, including personal protective equipment (PPE) and communication systems, infrastructure upgrades or modifications to fire department facilities, and additional liability and compliance issues.

Local governments across Virginia are struggling to maintain necessary fire services in a time of increased call volume, level state funding, and declining volunteerism. More than 70 percent of fire departments in Virginia are volunteer organizations. If the proposed rule goes through in its current form, it will pose yet one more challenge to local governments in the form of an unfunded mandate. We respectfully request that you reconsider the effect of the proposed regulations on fire departments and local governments.

Scott County Hosts Dynamic Region 13 Meeting

Counties in VACo Region 13 congregated in Scott County on June 11 at the Daniel Boone Wilderness Trail Interpretive Center to discuss important issues facing localities in the region and assist VACo staff in crafting the Association's legislative program for the upcoming 2025 legislative session. This was the third of eight regional meetings scheduled for 2024.

The meeting began with staff from the Daniel Boone Center welcoming us all to the Center and giving us an overview of the historically important role Daniel Boone and the wilderness trail played in America's westward expansion.

We were delighted to be joined by Delegate Terry Kilgore as a guest speaker for the event. Delegate Kilgore began by going over some key budget highlights that are of note to counties and specifically for those in region 13. This includes the 3% raise for state police and local constitutional officers, K-12 funding, funding for a planned inland port in southwest Virginia, as well as funding for mental health services and housing. While there are many successes on which to build, Delegate Kilgore mentioned items that he and his staff are focused on heading into the 2025 session. The Delegate is keenly aware of the local share that goes into the K-12 raises and funding and discussed ways to improve state funding mechanisms to better help southwest Virginia counties. The Delegate encourages data center development in the region coupled with the development of Small Modular Reactors (SMRs) for economic development benefits. Lastly, Delegate Kilgore mentioned the great work being done by the Tobacco Commission and partners regionally to further enhance economic development and encourage paths forward to develop middle income housing in the region so the workforce can keep pace with jobs growing in the region.


Next on the agenda was an opportunity for a representative from each county to outline top issues or legislative priorities. Several issues emerged as common areas of concern, including housing, dilapidated buildings, public safety, unfunded mandates and education funding.

Discussed often was the topic of housing, including housing affordability and the infrastructure needed to coincide with this type of development. Counties regularly discussed the need for more housing in the region as well as creative ways to use economic development funds to help with the infrastructure needed for housing development. Counties expressed the need for assistance in removing or redeveloping dilapidated buildings, which can be expensive but also vital to economic development. Counties in the region expressed concern with many issues in public safety including law enforcement officers being taken off the road and out of the county to transport individuals who are subject to Temporary Detention Orders, dwindling numbers of volunteers to support fire and rescue services, and costly equipment. Counties in the region are looking for solutions to the public safety problems they face. Counties in the region discussed the difficulties faced with unfunded mandates such as the resources needed to administer elections, as well as challenges posed by limited state support for Constitutional offices. Lastly, education funding and school capital needs were discussed as they have been at many recent VACo meetings.

VACo is grateful to the regional members; Cody Mumpower, Deputy District Director in Congressman Griffith's office; Tyler Lester, Legislative Director for Senator Pillion; and business partners who participated in the meeting. VACo would like to give a special thanks to Delegate Kilgore for speaking to the group. Lastly, VACo would like to thank Scott County and the staff at the Daniel Boone Wilderness Trail and Interpretive Center for hosting and sharing their wonderful facility with us.

Behavioral Health Commission Meets at Central State Hospital to Discuss System Needs and Improvements



The Behavioral Health Commission met on July 9 at Central State Hospital and received briefings from Department of Behavioral Health and Developmental Services Commissioner Nelson Smith, Central State Hospital CEO Brandi Justice, and Chinh Vu, Director of the Office of Construction Management for Special Projects at the Department of General Services. Dr. Justice discussed the hospital's history and its current role, and Mr. Vu led a presentation from DGS staff and the project architects on plans for a new Central State Hospital facility, which is designed to provide a more therapeutic environment and enhance safety for patients and staff. Under DGS's current timeline, patients and staff are scheduled to move into the new facility in early 2027.

Commissioner Smith <u>updated</u> members on key components of the Administration's Right Help, Right Now initiative. Improvements to the crisis system are in process, but challenges remain in the state hospitals. Commissioner Smith explained that the state has exceeded a national standard that would call for 64 mobile crisis teams; Virginia now has 98 teams, and is working towards a goal of 140 teams statewide. The state is also working toward meeting a national standard for crisis stabilization units and crisis receiving centers. Although state hospitals have experienced a drop in overall civil Temporary Detention Order admissions in the last two fiscal years, forensic admissions have increased significantly in the last ten years, a situation that continues to stress state hospital capacity, particularly in certain hospitals. Individuals admitted for restoration of competency to stand trial often have lengthy stays in state hospitals (the average length of stay for these patients is 106 days). DBHDS is taking several approaches to address this "forensification" of the state hospital system, including establishing a pilot unit to provide restoration services at a jail and examining current hospital processes, to include timeliness of forensic evaluations and forensic discharge protocols.

Commissioner Smith also reported on several other agency initiatives, including the establishment of a performance dashboard for Community Services Boards, and the creation of the Adult Psychiatric Access Line (APAL). This program is modeled on the Virginia Mental Health Access Program, which helps children's primary care providers to support patients' behavioral health care needs by offering education to providers, telephone consultations with specialists, and care navigation assistance. The APAL program will provide similar assistance to primary care providers and emergency clinicians in serving adults.

The Commission's next meeting is scheduled for September 10.

Virginia Chesapeake Bay Local Government Advisory Committee (LGAC) Members to Host Roundtable Discussions for County Leaders



Science. Restoration. Partnership.

The Virginia delegation of the <u>Local Government Advisory Committee</u> (LGAC) has planned two roundtable discussions for local government leaders to weigh in on key elements of the Chesapeake Bay Program's (CBP) work that has the potential to impact local governments. One of the more important topics expected to be covered at these meetings is the potential impacts and outcomes the Chesapeake Bay Program Beyond 2025 draft report may have on local governments. This report prioritizes and outlines the next steps for meeting the goals and outcomes of the *Chesapeake Bay Watershed Agreement* leading up to and beyond 2025. Here is the <u>full draft report</u> and a <u>FAQ</u>.

Discussion topics will also include land-use planning, state/federal stormwater regulations, funding for local governments and more. Feedback from the discussion will be incorporated into formal recommendations from LGAC to federal and state decision-makers.

SCC Taking Public Comment Regarding Towing Fee Regulation



On June 21, 2024, the State Corporation Commission (SCC) entered an **Order Establishing Proceeding (Order)** and opening a docket (Case No. PUR-2024-00104) concerning **Chapter 245 (SB 450 Marsden)** of the 2024 Va. Acts of Assembly.

Chapter 245 directs the SCC to examine the regulation of certain towing fees charged for the removal of motor vehicles, trailers, and parts thereof left on private property in violation of § 46.2-1231 of the Code of Virginia and for the removal of trespassing vehicles under § 46.2-1215 of the Code of Virginia. Chapter 245 further directs the SCC to identify policy options for the SCC to assume all or part of such regulation. As stated in Chapter 245, such policy options are to include various levels of SCC involvement in such regulation. Further, and as provided in Chapter 245, each policy option is required to:

- (i) identify the necessary statutory and regulatory changes to enact such policy option and,
- (ii) include the resources needed by the Commission to fulfill its duties under such policy option. Such resources may include additional staffing, funding, or training as well as the information needed from operators, localities, or other sources.

On or before August 15, 2024, any interested person or entity may submit comments concerning the matters and issues described in Chapter 245 for the SCC's consideration.

Sonoma County's James Gore takes the lead at NACo

Surrounded by his family, Sonoma County, Calif. Supervisor James Gore was sworn in July 15 as NACo's new president at the association's Annual Business Meeting at the Tampa Convention Center in Hillsborough County, Fla.

The California native leads the NACo executive committee, which includes First Vice President Judge J.D. Clark of Wise County, Texas; Second Vice President Commissioner George Dunlap of Mecklenburg County, N.C. and Immediate Past President Commissioner Mary Jo McGuire of Ramsey County, Minn.

Dunlap was elected in a three-way race, getting 67% of the vote or 1,658 votes with Charlotte County, Fla. Commissioner Bill Truex garnering 20% or 488 votes and Cascade County, Mont. Commissioner Joe Briggs taking 13% or 326 votes.

Rounding out the executive committee are regional representatives Tammy Tincher of Greenbrier County, W.Va., who takes over as the new Northeast Region representative and Supervisor Kurt Gibbs of Marathon County, Wis., as the new Central Region representative. They round out the regional representation which includes Briggs as the West Region representative and Commissioner Ron Berry of Roane County, Tenn., as the Southern Region representative.

Family: A running theme in Gore narrative

Gore was sworn in by his daughter Opal as his wife Elizabeth, son Jacob and other family members looked on.

"How about those kids?" he said as he took the microphone before about 3,000 county officials from across the country. "As we walked in here this morning, I looked at my kids, Opal and Jacob, and said, 'You know how there's all kinds of problems in the world, right? Well, you see all those people? They are the ones fixing things. These are the ones fighting for us...all of us."

"They are the ones delivering results," Gore said. "And kids, the only real results in this world come from imperfect, relentless progress. There is no progress that is perfect."

'We the counties...'

Several times during his speech, Gore made a point to include everyone in the audience. In fact, "we" was not only a running theme in his speech but it's the theme of his upcoming year as NACo president: "We the counties, we the leaders and we the future." The theme leads up to next year's Annual Conference in Philadelphia, as preparations get underway for a celebration of the country's 250th birthday.

At times during his address, Gore sounded like a Sunday preacher delivering a sermon to his flock. "Like you, I step boldly into the chaos of local public service, each and every day, for one reason," he said. "Because I refuse to subject my kids to a pessimistic future. I refuse to subject my kids, your kids, and all of the kids out there to a fatalistic tomorrow.

"How about you? Are you with me? Raise your hands if you're with me. And now, give a high five to the person sitting next to you and thank them for working with you, imperfectly, relentlessly, in those trenches of democracy.

"In church, we call this passing of the peace. Today, we'll call it the passing of the purpose."

'Embrace the mess'

Gore gave a nod to some of the divisions roiling the country. "Because even though it's one of the hardest things to do, living with gratitude, and embracing grace, is the only way to rise above, and not succumb, to the angst, the dismay, and the anxiety that threatens our democracy," he noted.

"Those words. Angst. Dismay. Anxiety. They speak to a general, almost universal sense of unease that surrounds us these days," he said. "You all know what I'm talking about. This malaise. Yucky. Fearful. Angry. 'Not happy with the now.' And not confident in the future. We serve our communities as public leaders through disruptive times: Climate extremes, natural disasters, societal clashes.

"Neck deep in the midst of a disruptive digital revolution, sometimes called the Third Industrial Revolution, where technology and Artificial Intelligence fly ahead of us so fast, we can't seem to keep up.

"We have an economy that is upside down, with more than 70% of Americans living paycheck to paycheck," he said.

"Sounds nasty, doesn't it? So why would I stand here before you all and give voice to this malaise...this mess? Because the only way through the storm is through the damn storm. The only way through the mess is to embrace the mess."

Leading with courage

"And to do that, we have to lead with courage," he said. "The courage to say what needs to be said and do what needs to be done. The courage to be disliked for doing that.

"But also, what about a different kind of courage? How about, the courage to laugh in the face of the storm? To smile and find camaraderie and shared purpose and dare I say it, joy? Joy within the mess?

"Isn't that what we're doing here? Isn't that why we're all here, with NACo, at this conference? Sure, we're here to share best practices," he said. "To learn from each other, and leverage solutions. Sure, we're here to advocate for federal policies that help us improve our communities, absolutely.

"But also, aren't we here to embrace that 'Get Stuff Done' attitude, together, as members of the middle?" he asked. "No, I am not talking about the political middle, I am talking about the radical, practical, passionate middle. Where real life happens."

'We're the ones we've been waiting for'

"And you know what? We are the ones we've been waiting for. We. Just like the founding of our country, it started with, 'We the People. We the Counties. We the Leaders. We the Future."

"And as we embark on our work this year, as we march toward our 250-year anniversary, we will deploy our resources to investigate, study and highlight the best of the best, bubbling up from our counties. From the ground up.

"We are going to drive our organization, our message toward this marker. Because even though it's a huge moment for our country, it's also just another day in business, for us at the local level. We have delivered, we do deliver, and we will continue to deliver, relentlessly for our communities."

Governor Glenn Youngkin Announces \$20 Million for Historic Preservation Capital Improvements Ahead of Nation's Semiquincentennial

RICHMOND, VA – Governor Glenn Youngkin today announced that the Virginia 250 Preservation Fund has been launched ahead of the 250th anniversary of the 1776 U.S. Declaration of Independence. The Department of Historic Resources (DHR) will administer the \$20,000,000 state funds for historic preservation projects across Virginia.

Funding for this new program was prioritized in Governor Youngkin's recent biennial budget and the **2024-2026 Virginia Biennial Budget bill**. The purpose of the special fund is to support capital improvement projects at historic sites and museums that anticipate a significant increase in visitation during the upcoming semiquincentennial in 2026.

"The Virginia 250 Preservation Fund is critical to ensuring that Virginia is prepared to host millions of Americans for the semiquincentennial celebration of our glorious history. As home to Washington, Jefferson, Madison, Monroe, Patrick Henry and the Battle of Hampton to the Siege of Yorktown, Virginia was at the forefront of our history. Bolstering our historic sites and museums will not only encourage and aid tourism, it is our responsibility as stewards of American history," **said Governor Glenn Youngkin.**

"As a result of Governor Youngkin's outstanding leadership, we have this vital capital improvement funding. The enhancements made with this funding will not only prepare us for the semiquincentennial, they will have lasting impacts for generations to come. Americans nationwide, not only Virginians, will benefit tremendously from this Fund," said Virginia Secretary of Natural and Historic Resources Travis Voyles.

"The Department of Historic Resources is incredibly grateful to Governor Youngkin and the General Assembly for providing this essential funding. We are so excited to work with Virginians to support our historic sites and resources in anticipation of our nation's 250th birthday," **said Director of the Department of Historic Resources Julie Langan.**

DHR has designed a grant program, consisting of a two-step application process, by which these funds will be distributed for capital improvements at significant historic sites and history museums in the Commonwealth. Preapplications are being accepted until August 30. Those projects that advance will have until October 14 to submit a full application.

Eligible applicants for the Virginia 250 Preservation Fund include nonprofit organizations that are registered as tax exempt under the Internal Revenue Code; Virginia localities as defined under **Code § 1-221**, **and** state-or federally-recognized Indian tribes in Virginia. All applicants must be the owner of the project property or be able to submit a signed letter of support from the property owner and a copy of the recorded deed.

The Department invites all historic sites or museums that meet the requirements specified above to apply. History museums in non-historic buildings are also eligible for funding, but priority will be given to projects featuring properties listed in the Virginia Landmarks Register (VLR) and/or the National Register of Historic Places (NRHP), properties designated as a National Historic Landmark (NHL), or properties determined eligible for any such listing by DHR.



VOF opens \$1.7M grant round for open-space projects



VIRGINIA OUTDOORS FOUNDATION

The Virginia Outdoors Foundation (VOF) is making \$1.7 million available from its Preservation Trust Fund program for grants that protect open space.

Preservation Trust Fund grants for the fall 2024 grant round will prioritize projects that result in significant public access, but funds may also be used for projects that protect exceptional conservation values such as water quality, historic and cultural resources, wildlife habitat, and high-quality farmland and forestland. A real estate interest must either be acquired by a local government or conveyed to VOF to be eligible for funding, and protection must meet the requirements of Virginia's Open-Space Land Act. Applications must be submitted online by 5 p.m. on August 8, 2024. Eligibility requirements, sample applications, a timeline, and other materials may be found online at https://vof.org/ptf.

VOF will host a one-hour Preservation Trust Fund Grant Workshop Webinar on Tuesday, July 2, 2024 from 1-2 p.m. using Microsoft Teams. The webinar will address key program requirements and criteria, provide guidance on material to submit with the application and share tips on navigating the grant portal. You are not merely a customer of VAcorp; you *are* VAcorp! We are both owned and governed by you – our members! VAcorp is created under 15.2-2700 of the local government code where all assets and surplus belong to the members. In addition, VAcorp is controlled by a Supervisory Board that is elected from and by our members. The Board determines and approves all major risk pool decisions, and as a voting member, you have a voice in the decisions that matter most.

Know Who You Are

Because you are VAcorp itself, we think it is critical that you understand exactly what VAcorp is and why it exists. Many simply think of us as their "insurance carrier" – writing customized coverages and handling claims when they occur – but we are so much more!

Our History

The Birth of Risk Pools

VAcorp is not an insurance company, but rather a Risk Pool.

Unstable economic conditions in the mid-1980s led to a commercial insurance crisis with ballooning premiums and widespread policy cancellations. As a result, Risk Pools began to form as an alternative to volatile traditional carriers, allowing Pool members to exert more control over their coverages and costs. Today, almost all public sector entities throughout the country get their coverage from Risk Pools rather than from commercial insurance companies.

VAcorp's Origin

VAcorp was founded by a handful of Virginia counties in 1993. The ultimate goals of the program were to provide **cost stability**, the most **comprehensive coverages** possible, and **custom services** tailored specifically to the unique needs of our members. While we are pleased by how well our prices compare against the competition, our goal was never to guarantee the lowest cost. Instead, we promised to avoid the wild price swings that we've seen in other providers and provide stable pricing year after year, and that is exactly what we have delivered. VAcorp rates are actually **lower today in 2024 than they were in 1993!**

VAcorp's Growth

Today, VAcorp is the **largest self-insurance risk pool** for public sector entities in the Commonwealth with a membership retention rate of better than 98%. Over the years, we have expanded beyond counties to include municipalities, school divisions, authorities, volunteer fire & rescue companies, state agencies, and non-profits funded by taxpayer dollars. **Over 560 members** have joined VAcorp, including 8 of the 10 largest counties, 8 of the 10 largest cities, and 8 of the 10 largest school divisions. We believe that the extraordinary success of the program can be attributed to our unwavering commitment to our founding principles.

VAcorp Exists to Serve You

- 1993 VAcorp is established with 12 founding members and less than \$700,000 in annual contribution.
- 1998 VAcorp terminates service contract with claims administration vendor and hires staff to promote more control and efficiency.
- 1999 VAcorp offers coverage to K-12 Public Schools across the Commonwealth.
- 2001 VAcorp begins offering Public Officials Liability coverage in response to VArisk offering limited coverage.

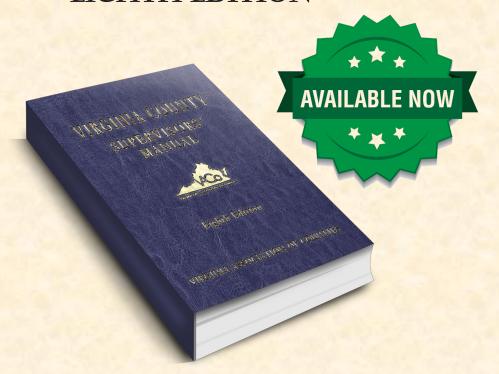
