The position also provides oversight for the County's Locally Administered Transportation Programs through the Virginia Department of Transportation, the Rural Additions Program, and other transportation initiatives. The position acts as a liaison to the New River Valley Metropolitan Planning Organization and the Roanoke Valley Alleghany Transportation Planning Organization. The Planner II will also assist with the development of applications for transportation funding opportunities and will help to execute the transportation goals outlined in the County's Comprehensive Plan.

The position requires a Bachelor's degree in Planning, Urban Development, Civil Engineering, or a closely related field, with two years of related experience. The ideal candidate should be organized, detail-oriented, and able to multi-task with a high level of accuracy; and have knowledge of law and government, including legal codes, regulations, and agency rules. Applicants should have a demonstrated ability to understand and follow written and oral instructions, work seamlessly with team members and independently on tasks, enjoy assisting people, and have strong communication skills and excellent customer service skills. The selected candidate is expected to obtain the Locally Administered Projects Qualification through VDOT within 1 year of hire.
