## Statewide Grants and Awards to Date

#### City-County Awards

- Received applications that include 106 of the 133 Cities and Counties
- Awarded 100 of 110 applications
- Total awarded to date = \$46 million
- 92 projects currently active

#### State Agency Awards

- Received proposals from 18 agencies that included 48 projects
- Awarded 36 projects totaling \$20 million
- 32 projects currently active


#### Grand Total over 15-month period

- Received funding requests for 158 projects
- Awarded 136 projects totaling \$66 million



## **Cities and Counties Distribution**




<u>Wise County</u> % of Population = 0.41% % of Allocation = 1.76%

## Clarifying OAA's Gold Standard Incentive

OAA Staff has heard feedback which led us to determine that in disseminating information for this program, we unintentionally created some incorrect assumptions.

#### What is required to access Gold Standard Incentive funds?

- Submit a 1-time application to OAA pledging to apply the Commonwealth's standards to funds received directly from the settlement administration (Direct Distribution). The requirements are:
  - 100% abatement use
  - No supplanting
  - No prior year costs
  - No indirect costs
  - Report usage of Direct Distributions to OAA annually
    - Assumption this creates additional reporting and administrative burden
    - **Clarification** the reporting of usage of Direct Distributions to OAA is required for participation in any OAA grant. One report per year satisfies for Gold Standard compliance as well as all Individual Distribution and Cooperative Partnership applications

## Clarifying OAA's Gold Standard Incentive

### Why is OAA offering the Gold Standard Incentive?

- To *increase* abatement funding *resources* for Cities and Counties
- To *incentive* Cities and Counties to use Direct Distributions *in ways that maximize* the amount of funds *impacting citizens and communities* (helping save lives) due to lessons learned from the tobacco settlements
- To make it *easier* on Cities and Counties to ensure the usage of the Direct Distribution *complies* with all the various settlements and their various requirements that govern Direct Distribution usage
  - The Gold Standard requirements *are stricter* than the settlement requirements
    - Assumption: We don't need anyone's help with determining appropriate usage of Direct Distributions
    - **Clarification:** This is just another advantage of the incentive and not meant to be an assessment of abilities
- To help **ensure** the Commonwealth and Cities and Counties **stay in compliance** with settlement requirements
  - Assumption: This is just more state government red tape and big brother overreach
  - Clarification: The Commonwealth and all 133 Cities and Counties share the responsibility and liability of compliance. If enough parties end up out of compliance, the settling companies could petition to re-open the settlements and the all parties will end up with fewer settlement dollars to help citizens and communities
- To help create a *full view and tracking* of Virginia's usage of settlement funds
  - State agencies receiving funds from the Commonwealth's share (COAR fund) are required to report usage



# Prioritization of Competitive Awards

- Geographical distribution based on the five Department of Behavioral Health and Development Services (DBHDS) regions
- Opioid-related harm per capita (during the time the harm was alleged to have been caused by the defendant companies).
- Economically disadvantaged communities.
- Programs run by organizations with a record of success.
- Programs and efforts that are evidence-based.
- Local cash match, with more priority given for higher matching amounts.

# More about the "Local Match"

- Must be cash not "in-kind" services
- Must be in addition to current levels of expenditures
- Can come from the one or more of the city or county's
  - Direct Distributions
  - Individual Distributions
  - "Gold Standard" Incentive Funds
  - General Funds
  - Other Grants
  - Funds provided on behalf of

Separate Application *not* required. Process to allocate included in Cooperative Partnership Application

# Trends, Challenges, and Strategies

### Many Cities and Counties are not applying for their "Individual Distribution" grants

- The OAA Board of Directors has adopted a policy for cities and counties to apply for their Individual Distribution amounts within five consecutive application periods from when the funds were made available.
- Individual Distribution funds available in FY2023 must be applied for by April 1, 2028
  - For FY2024, applied for by April 1, 2029, as so on

Implementation of the proposed programs/efforts – realistic timeframes needed

• Proposed performance measures and implementation timeline are important!

Lack of clarity about partners/subcontractors involved: CSBs, Non-profits, Private providers, etc.

• State and local procurement laws and policies still must be met!

# Trends, Challenges, and Strategies

The amount of planning and research into a proposed program is evident

- Well planned programs have more partners and supporters
- Well planned programs tend to "sell" themselves better
- Collect feedback from the community including stakeholders
- Define the problem and proposed solution
- It takes time to pull everything together and get approval from governing bodies and refine applications

OAA often receives applications that are incomplete or have problems, but no one has reached out for assistance or to review prior to submission.

- Contact OAA to discuss ideas and get feedback on how to formulate applications
- Utilize Regional Resource Coordinators and OAA Staff
- Utilize the optional OAA draft review prior to the application deadline


# Trends, Challenges, and Strategies

### Budget/Financial Issues


- STRONGLY recommend involving experienced budget/finance staff with the planning and writing of grants!
- Many applications contain good projects, but the math is all wrong
  - Focus on projects that are both programmatically and financially sound
- Sustainability of OAA-funded efforts frequently not addressed.
  - Increasing matching funds
  - Leverage generated revenues
  - Combining with other grant funds
- Develop short- and long-term plans that account for all the city/county opioid settlement funding pots:
  - Direct (non-competitive)
  - Individual (non-competitive)
  - Gold Standard (non-competitive)
  - Cooperative (competitive)



# Current City/County Grant Application Cycle

#### City and County Application Cycle is Open (3<sup>rd</sup> round)

- Open October 1, 2024, through April 1, 2025
  - Grants Committee will consider current year (FY25) applications:
    - December 6, 2024, and February 21, 2025
    - Next fiscal year (FY26) applications will be considered May 23, 2025
- All applications will be submitted through the Grants Portal

#### Applications for December 6, 2024, Grants Committee

- Received 9 Individual Distribution applications
- Working with fiscal agents on 4 Cooperative amendments

#### City and County Reporting

- Cities and Counties have completed carryforward true-up and annual reports for FY2024 awards
  - Letters confirming finalized carryforward amounts sent
- Staff will soon send out progress reporting forms for planning grants



### County Grant Highlights

#### Dickenson County – Wildwood Health & Wellness Center

- Cooperative Partnership with Dickenson County as the fiscal agent, partnering with Lee and Scott Counties
  - Awarded \$1,709,675 for FY25
- Comprehensive Recovery Supports Facility

### Henrico County – Kinship Navigator

- Individual Distribution
  - Awarded \$80,231 for FY25
- Providing supports for placing children with parents struggling with substance use disorder (SUD) with kin or fictive kin family members to keep them out of the foster system

#### Henrico County – Pregnant & Parenting Women with SUD

- Cooperative Partnership with Henrico County as the fiscal agent, partnering with Charles City and New Kent Counties
  - Awarded \$856,638 combined between FY24 & FY25
- Providing specialized services and supports to pregnant and parenting women with SUD including linkages to treatment, medication for opioid use disorder (MOUD), mental health services, peer support, employment, and housing
