- Corresponding with state and federal level legislators and staff;
- Identifying transportation funding opportunities applicable to Fairfax County's transportation priorities, such as federal, state, and/or regional grants;
- Assisting with the preparation of requests for transportation funding, including collaborating with FCDOT project managers to develop grant applications with related cash flows and justifications;
